- 1. The minutes of the last meeting were accepted as read.
- 2. Actions outstanding. All actions have been completed apart from: -

Action on **RJB** to develop a registry of the county's rare and/or scarce breeding birds is ongoing.

Action on **RJB** to develop a historical register of migrant bird's first and last dates is ongoing.

- 3. Given the urgent need to prepare a dataset for the commencement of the 2017 annual report, the chairman said that the meeting should concentrate on making final decisions on outstanding Category 2 and Category 3 records.
- 4. Policy for the review of unsupported records. Records of scarce or rare birds that lack photographs or descriptions of an acceptable quality are a problem common to all counties. The BRC solution is to temper objective review with subjective intervention should a committee member be particularly familiar with the species concerned, the location or the observer. No method is perfect, but the Berkshire solution is better than most.
- 5. Given the methodology outlined above, the need to maintain two categories of scarcity (Category 2 and Category 3) has been questioned. There was some discussion on this issue, but it was decided to keep the two categories for the present.
- 6. Review of outstanding 2017 Category 2 records. Adjudication decisions were made on all outstanding or pended records apart from: -

Purple Sandpiper at QMR on 30th October 2017

Arctic Skua at QMR on 25th September 2017

Lapland Bunting at Lambourn on 22nd December 2017

8. MFW provided a summary of the BRC review of 2017 records.

The BRC reviewed 446 records. 367 (83%) were accepted. 11 (3%) were considered 'not proven'. 6 (2%) were pended, awaiting further details. No documentation was received for 62 (4%) records.
